I wanted to talk to you about how you'd like for this to work. We do require a \$2000 down payment for a bilateral procedure. I know that you were approved for Care Credit for \$3500. Would you want to use that as your down payment? It would be a matter of financing the remaining \$1300. Here's how it would break down: You would pay an approximated monthly payment of \$146 per month for 24 months to Care Credit. You would also pay an additional payment of \$72 per month for 18 months to YourHealthCredit. This would be an estimated total of \$218 per month. The next step for you to proceed with surgery is to have your measurement exam. You'd have to be out of contacts for 10 days prior to this appointment. If you could be out of your contacts by next week, we could schedule you for the October 18th surgery date. Let me know if this works for you. Please email or call me at your convenience.
